Enclosed is a Low Income Abatement and Property Tax Credit Application. The following information is provided to answer some basic questions and eliminate mistakes which may result in you not receiving the abatement.

The 2024 maximum annual income is \$40,840. This includes income from *all* members of the household in 2023.

- You must be <u>65 years of age OR younger</u> by December 31st 2024 to apply for this credit. If you do not meet this qualification, please contact this office. You may qualify for a different program.
- · You must either be disabled, on disability or under extreme hardship to qualify for this abatement.
- IF YOU ARE APPLYING UNDER A DISABILITY, you must provide a statement from a medical doctor stating the facts and the extent of your disability and whether it is a permanent or temporary disability. If you have filed previously and your disability is unchanged, we will not require a new medical statement but one can be requested.
- If you are filing for the first time because of a disability and do not provide a letter from your medical provider, your application will be returned.
- **IF YOU ARE APPLYING BECAUSE OF EXTREME HARDSHIP**, furnish a statement setting forth the facts of your hardship and copies of your 2023 income tax return. You may also furnish copies of high medical bills, or statements regarding any other circumstance you feel may apply.
- ANY application claiming hardship will be returned unless accompanied by your statement and tax returns.
- Make certain you enter your property tax serial number or account number so your property can be identified.
- Be sure to include a copy of your 2023 Federal Tax Return and supporting documentation. Your application will be returned without it.
- You must file every year to possibly qualify since the amount of the abatement is based, in part, with the prior
 year's income and need. Do not assume you will automatically receive an application each tax year. Every
 effort is made to send an application to individuals who filed the previous year, however if you have not
 received an application by July of the current tax year, call the number listed below and request one.
- **<u>Do not</u>** send the application to the State Tax Commission. They do not process these applications and do not forward them onto the respective county.
