- June 21, 2022: Current to within three (3) days of the date of filing. Primary Election Candidates. Unopposed local school board candidates do not need to file this report.
- July 28, 2022: Final Statements are due from candidates who were **eliminated** in the Primary Election.
- November 1, 2022: Reports are due from **all candidates** who will appear on the General Election ballot. This should include all receipts and disbursements from the date of the last report filed to current within three (3) days of the date of this filing.
- January 3, 2023: Final report filed by **all General Election candidates** or their campaign committee. The final statements shall include all contributions and disbursements through December 31, 2022.
