General Election Information

Ballots will be mailed out to all eligible voters beginning October 13, 2026. Voters must be of legal voting age, a citizen of the United States, and a resident of the voting precinct in which they are registered. If you have re-registered by the below deadlines, we will mail you a ballot to your new address. Nov 3:	Ballot MUST be received by election officer by 8:00 p.m. on Election Day
Nov 3:	Election Day; see Election Day locations, date, and time below
Nov 3:	Unofficial Election results will be posted after 8:00 p.m.
Nov 10:	Election Audit at 10:00 a.m. in clerks office
