RESERVATION GUIDELINES FOR THE IRON COUNTY SHOOTING RANGE

- Iron County Shooting Range amenities are as follows: (The special event range requires advance reservation)
 - 300 yd. Range with concrete pads, nine concrete shooting benches, and one shooting bench with awning.
 - 1000 yd. Range with concrete pads, two adjustable metal shooting benches, and steel AR500 Targets from 200 yd. to 1000 yd.
 - Six short range bays, all having concrete pads. Three north and three south facing.
 - North facing are 50 yds. deep and can be used for pistols, rifles & shotguns. Two have awnings.
 - South facing are 40 yds. deep and are used for PISTOLS ONLY. One bay has an awning.
 - One Special Event Range which includes six bays at 45 yds. each. All firearms are allowed in this area. There is one long sunshade awning in the first bay.
 - Two double vault toilets
 - Trash cans
 - Emergency Satellite Phone
 - No water or electricity are present
- As of January 1, 2024, Iron County Parks & Recreation charges a non-refundable fee for the use the of the Group Range at the Shooting Range.

The fees are as follows: (No Exception

- Groups up to 25 people will be \$25.00 per day, per reservation.
- Groups of 26+ people will be \$50.00 per day, per reservation.
- Schools K-12 are Free
- The reservation season for the Group Event Range at the Shooting Range is on a Year-round basis.
- No reservation requests are accepted for other than the current year.
- NO RESERVATION APPLICATION WILL BE ACCEPTED UNTIL THE <u>FIRST WORKING DAY</u> OF THE CALENDAR YEAR. You may review the reservation calendar for the Group Event Range on the Iron County website at www.ironcounty.net under "Parks & Recreation" in the Departments section. Park ordinance are on the website for your review prior to making your reservation.
- A reservation request form MUST be filled out and presented with applicable fees, in the form of cash, check, or credit card
 to the Iron County Parks & Recreation Office at 581 N Main St., Cedar City, between the hours of 8:30 am to 5:00 pm;
 Monday through Friday. Reservations will only be confirmed by the reservation coordinator and upon receipt of payment.
- A 2 week temporary hold may be placed to save a requested date. If not confirmed within this period, Iron County reserves the right to offer date to another party.
- The Reservation Application may be picked up at the Cedar City Visitor Center at 581 N Main St., Cedar City, or on the county website at www.ironcounty.net. Under the "Departments" section, select "Parks & Recreation", then "Reserve a Pavilion".
- Use of this facility is a privilege and any abuse or damages incurred may result in termination of the users privileges at the Range.
- Use of the Range does not imply endorsement of the users policies, beliefs or programs by the Iron County Commission and/or staff.
- Special Events are required to obtain a permit and supply additional documentation such as liability insurance, Medical
 and Law Enforcement notifications and are also subject to a \$500.00 fee. Please contact the Parks & Recreation Director
 well in advance to start your permit process.
